tapestry; yes, even look at the periphery to appreciate what has long since been forgotten, yet waiting around the edges for me to notice. ## FEATURE ARTICLE: What IS Instructional Design?

You may be thinking about a career as an instructional designer, but still have questions about what this means. In a nutshell, instructional design is curriculum development – creating training materials. But, there's more to it; that's why this article was written – to examine what Instructional Designers actually do!

You'll also learn about the process of a typical instructional design project from start to finish, and the different roles and responsibilities involved. You'll gain a better understanding of this exciting profession and where to find further information.

## Jobs in Almost Every Industry

Instructional designers create training materials. Professionals doing this kind of work include teachers, of course—from preschool through university and continuing education—but the field also includes many other job titles and types of work. Instructional design exists across most fields of human endeavor: in business, non-profit organizations, educational institutions, government agencies, and others. Think about where training and learning is needed (just about everywhere!) and you'll get an idea of how wide the field can be.

## Instructional Design Is Curriculum Development

When you're reading a newspaper, web site or a brochure, you may be learning something—gathering and (presumably) retaining information—but these materials were probably produced by a writer. Instructional designers are needed when an organization has specific goals to meet, where structure and logical sequencing are required. This may fall under the general heading of Training. In the business world, it may be called Performance Improvement, meaning teaching people specific tasks they need to know in order to do their jobs better.

An employee's performance can be tested. Were the required skills transferred during the training? Did they learn it or didn't they? Testing (assessment) is an important factor in evaluating the teaching and instruction. It's not only a test of the learner, but it tests the instruction itself, giving valuable feedback to the test creators, to refine the instructional design for future use.

All of these tasks, from determining the needs and requirements of a project to designing the training materials and assessing the learners and the instruction, are part of an Instructional Designer's job. Many people enjoy working in this field because it requires developing and using many different skills.

## "You Can't Get There From Here"

Creating instructional materials is a complex endeavor. How do you start? Fortunately, there are established road maps and guidelines that help lead the way. A typical development cycle follows a model commonly known as "ADDIE" (Analysis, Design, Development, Implementation, and Evaluation). Figure 1 describes the kinds of activities that occur during each stage.

Figure 1. The ADDIE Model: A General Outline of the Process

Analysis	Analyze the situation. Can the instructional issues be framed in terms of human performance? If so, what are the specific tasks that people need to do to reach the goals? If the goals are not task-based, are there are other ways to reach them besides training and instruction? The analysis phase looks at the big picture.
Design	Instructional strategies are planned and media choices are made in this part of the model. Perhaps you'll use video, a web site, computer-based training, or an instructor-led class. Maybe you'll create "blended learning" which combines self-paced, online learning with in-person classroom instruction.
<b>Development</b>	This part of the model is where the decisions made during the design phase are implemented and fleshed out. You contact subject matter experts to ensure that the information is accurate and complete. You may write, draw, chart, create audio, video or animation components, and put them all together.
Implementation	Often one module of a complex project will be completed and tested before continuing development of other modules. User (usability) testing with members of the target audience is conducted to see where improvements can be made. The product is then put into full production mode for completion. This may include training students and/or instructors in how to use the product (for example, a custom user interface for a new software learning tool might require training).
Evaluation	Evaluation means testing the learners and gauging the success of the instruction itself. Your assessments are both informal (based on observations during user testing) and formal (based on tests which are measurable and quantifiable).

ADDIE is only one of several models that can be used to help guide the process called Instructional Systems Design (ISD). This process may also be called Performance-Based Training (PBT), Criterion Referenced Instruction (CRI), the Systems Approach to Training (SAT), or simply Instructional Design (ID). Terminology varies, but the unifying keys are the need for and description of a process and a systematic approach. Look for these features in whatever process you follow:

- Competency Based (Job Related): Learners are required to master a Knowledge, Skill, or Attitude (KSA).
- Sequenced: Lessons are logically and sequentially integrated.
- Tracked: A system is established for efficient changes and updates to the training materials.
- **Evaluated**: Allows for continuous improvement and maintenance of training information.




Figure 2. Tasks Overlap During the Course of a Project

Whether you are a project manager or one of many contributors, you'll notice that the stages of your process will overlap. There isn't a clear-cut division of when one stage ends and the next one begins. Rather, while one stage is winding down, the next one is starting up. For example, after you've completed some initial research (Analysis), you may start designing some solutions (Design). When you've finished some overall decisions (Design), content creation can get started (Development). See Figure 2 below for an illustration of how this works over time.

This overlap is normal and beneficial, but caution is also required. The further along in the process that changes are made, the more costly they become. The old adage "Don't change horses in the middle of a stream" lends a useful picture. You can imagine that if you were already in the Development stage and the training medium were changed from online to video, you might have to rewrite or discard much of what had already been created and completed. If you decide to go ahead with the new plan, you'll have wasted precious time, money, and effort. People's time is very expensive, and these kinds of decisions must be made in light of the overall schedule and budget. Some instructional designers choose to stay away from project management because it can be very stressful, yet when a solid process is followed, these kinds of costly mistakes can be avoided. It's especially important not to skimp or leave out the initial Analysis phase, sometimes called the Discovery phase. Many instructional designers consider this the most important and exciting period, when information is gathered and possibilities remain open.

## What Do Instructional Designers Actually DO?

The answer is, "It depends." You may have one role with limited and specific responsibilities or you may have to wear all the hats, doing all the work yourself. It depends on the size and nature of the project, the kind of company or organization you're working for, and other factors.

Large instructional design projects may be handled "in-house" within a company or organization, or awarded to a small company specializing in instructional design and development of projects for other businesses and agencies. This small company could be *you!* If you are an independent contractor, you *are* your own business and responsible for everything. During each phase, you are *it*, the buck stops here! If you need help, you may hire subcontractors. You'll plan and monitor schedule and budget, making sure that timeline and finances are on target, you'll manage team members' work, and be responsible for quality assurance. Most independent contractors in any field spend several years working in an industry before striking out on their own. Instructional design projects are usually made up of small teams, with each person taking on a specialized role. At some point in your career, you may choose to specialize after finding which roles most appeal to you.

The following case study describes a company where training projects are usually completed by a small team of three people, each of whom has a different focus to his or her work.

## Greenpoint Mortgage - A Case Study

Ani Mukerji manages training projects for Greenpoint Mortgage at the company's headquarters in Novato, CA. Training is used to bring new employees up to speed in how to do their jobs, but also to teach groups of employees how to comply with new regulations within the company or from state and federal agencies. A short training program might be designed to teach people how to properly fill out complex forms. Ani's rule of thumb is that an online learning module may be needed if the audience for a particular training is greater than five hundred. If the audience is fewer than five hundred, the company may seek a more cost-effective solution such as instructor-led training or perhaps a short set of printed instructions. A typical Greenpoint training project takes about two months. The first week is devoted to gathering requirements and determining if an online solution will be best. The main question instructional designers ask is whether the training need is a performance issue, and if so, what are the required behaviors the learners need to master to achieve the desired business goals?

To develop an online course, a typical Greenpoint team consists of three people: 1) the Instructional Designer, 2) the Online Course Developer, and 3) the Visual Designer/Flash Artist. Each of these has the same job title, "Instructional Designer." All of them will do some course development during the Development and Implementation phases, but their overall roles are different. The Instructional Designer mentors the other two team members and is primarily responsible for monitoring everything and reviewing progress at regular intervals. The Course Developer writes most of the content in collaboration with subject matter experts. The Visual Designer/Flash Artist is in charge of graphic design—the look and feel of text and graphics—making everything look good on the page. Flash is used to animate parts of the presentation so the learning module is more interesting, engaging, and interactive.

## Subject Matter Experts



You're not expected to know it all! Instructional designers routinely consult with subject matter experts (SMEs) to get the information they need. An expert can be anyone from outside or within an organization—from a top executive managing a product line to someone working in the shipping department. You need to find out who knows what you need to know, and then work effectively with SMEs by being prepared. Value their time as you do your own. Do your homework and have specific questions prepared in advance. SMEs are often too close to the subject matter to be objective. It's your job to make their expert knowledge accessible to the neophyte. If the information is new to you, too, pay close attention to your own learning process. There may be background knowledge that SMEs take for granted that you need to include in the instruction. You are the advocate for the learner and the end user at all times, and this audience should always be foremost in your mind.

## Specialized Knowledge Areas

Employers usually select candidates with experience and expertise in their particular area, and it's no different when they hire technical communicators such as instructional designers. It may help your career if you specialize, especially if you're interested in a particular industry or field. If

you have, for example, an interest in mechanical engineering, a related degree, or work experience, you might enjoy working for a company that develops Auto-CAD software—training their customers and sales team in how to use their product. Instructional designers can find work across most fields and industries, but there are a few broad areas in which many jobs are currently found, such as the burgeoning fields of health care, biotechnology, computer software, engineering, and education. Technology's role in our society is growing exponentially, as is the amount of knowledge and information produced by our society on a global scale. There will be a continued and growing need for people who can leverage this knowledge and package it effectively and attractively so that others can learn.

Instructional designers create target objectives by pinpointing essential tasks that meet business and organizational objectives. Their specialty is in understanding the process. They don't need to have a complete understanding of specialized subject matter to do their jobs well. That's what SMEs are for! Instructional designers must be curious about the world. If you love doing research and learning new things, you may well enjoy this profession. Jane Smith has been an instructional designer for over twenty years and owns her own company, JEM Communications (<a href="www.jemcommunications.com">www.jemcommunications.com</a>). She says: "I can learn anything well enough to teach it to anybody...The more industries I go into, the faster I am because systems tend to work the same way...What's kept me fresh and interested in the field is that I've moved from industry to industry. I'm never bored!"

## Typical Routes into the Profession

There are no specific requirements for becoming an Instructional Designer. There are no State Licensing Boards as there are for doctors, lawyers, psychologists, or teachers—no credentials for which to apply or tests to pass. You can become an instructional designer by your own self-declaration! Having business cards printed is a good way to start because people will take you more seriously and you will begin to develop the mindset to help propel your career forward. Still, without specific work experience developing training programs, you'll have to create some samples to show what you can do.

When starting off in any field there's an initial "Catch-22"—it takes experience to get experience—but you can still start a portfolio. This is a collection of work, starting with one piece. A portfolio demonstrates your skills, preferably a broad range of abilities, and showcases what you want to do in the future. These projects may be personal (self-assigned), academic (fulfilling course requirements), or *pro bono* (done at low or no cost for non-profit organizations). Many non-profits will gratefully accept donations of services. They may even have a small budget for completing a specific project.

If you want to get practice building web sites and feel this will help your instructional design portfolio, find an organization in which you are interested and offer your help. Make sure that the final product will serve your needs as well as theirs and provide a good showcase for your talents. An organization that has received such a gift will be happy to write a glowing letter of reference. Make sure they know in advance that you will be using their site for your own online portfolio. They'll probably be thrilled!

Work experience is more important than academic degrees. In lieu of work experience, you have your portfolio, large or small, which proves your abilities. Remember that a portfolio can be as little as one piece. You can get a job without an academic degree but if you come out of your degree program without samples to show, you may have trouble finding a position.

Most job descriptions list a Master's degree as preferred but not required. Some employers may require a Bachelor's degree, but few if any will ask for a particular major. Undergraduate programs in Instructional Design and Technology are rare; however, there are many excellent and well-established Master's programs at universities across the United States. Prerequisites vary, but you'll need at a minimum to demonstrate competent English writing abilities, and you must be comfortable using computers and basic software applications such as Microsoft Word.

Don't be put off by a long list of requirements in a job description. Often these are "wish lists" describing the perfect candidate employers don't actually expect to find. This perfect person probably does not exist. If you think you come close and are interested in the kind of work the company does, by all means apply! Inevitably, there will be a range of experience listed. Sometimes this is negotiable, other times it is used as a screening filter. Look at it as a request rather than a requirement and don't be put off if your experience doesn't match exactly. Years of experience can also indicate the job level and give you an idea what salary range to expect:

- Zero to three years is an entry-level or junior position
- 3–5 years is mid-level
- 5–8+ years experience may be sought for a senior-level role

Larger employers such as governments and universities may have more stringent requirements and have less leeway in evaluating candidates. Sometimes work experience can be substituted on a year-for-year basis for a degree. The converse is also true. The California Office of the Courts, for example, will accept any valid teaching credential in place of one year of work experience.

## Where Are the Jobs?

Instructional design has much in common with technical writing, and they both rest comfortably under the broad umbrella of technical communications. The Society for Technical Communication (STC) is the leading professional organization for technical writers, yet many instructional designers belong as well. STC held its May 2006 annual conference in Las Vegas, with sessions entitled, "Creating Training that Adults Remember," "E-Learning Tools for the Web," and "Determining Instructional Methods," among many others, because technical writers are often called upon to create training and instructional materials. Some instructional designers may have "Technical Writer" or some other title under their names on their business cards.

This cross-over between fields is nowhere more evident than on Monster.com—arguably the most popular web site for job searchers. Monster is kind enough to offer similar job titles, so if you don't get enough results or you don't like what you see, you can try a different word combination. You'll have to read the job description carefully to find out what the work really entails. Look at the cross-pollination of job titles shown in Figure 3 (next page). A search for three different titles (Curriculum Developer, Instructional Designer and Technical Writer) yields many synonyms. Training Specialist is offered for all three and the word "Training" is a common theme.

Technical writing has been established and recognized longer than the relatively new fields of instructional design and educational technology. The U.S. Bureau of Labor's *Occupational Outlook Handbook* mentions technical writers under "Writers and Editors" but there is no listing for Instructional Designers. You will find Instructional Coordinators but this is not the same thing; they evaluate and recommend textbooks and curriculum for school districts.

Figure 4 compares keyword searches for a number of terms common to the everyday job responsibilities of Instructional Designers. Although a job search for Technical Writers shows more results than a search for Instructional Designers (1,197 compared to 262 on HotJobs) this is misleading, because there are more alternative titles for people doing instructional design than technical writing. However, there are more instructional design jobs than it appears. Both HotJobs and CareerBuilder returned over 100,000 listings containing the word "training." Because of naming irregularities, it's impossible to determine exact figures, but job options in the field of instructional design and training are much more diverse than for technical writers.

## "No More Boring e-Learning!"



"e-Learning" is now a generic yet still a relatively new term. The <u>glossary</u> at Hobson's MBA Central defines e-learning as "education using electronic delivery methods such as CD-ROMs, video conferencing, websites and e-mail...often used in distance-learning programs." Michael Allen, Chairman and CEO of Allen Interactions, calls for "No more boring e-learning!" and the exciting work his teams produce exemplify this credo (<u>link to case</u> studies).

In Michael Allen's "Guide to e-Learning," he writes:

"Good design is essential for success but uncommon in e-learning. Perhaps this is because teaching is confused with presentation of information or perhaps because so much attention is given to technology that little remains for dealing with instructional concerns. Whatever the reason, good design can't be achieved without careful attention to learner motivation, user interface, content structure and sequencing, navigation, and interactivity...striving not only for accuracy and clarity, but also for highly motivating, meaningful, and memorable events."

Mr. Allen stresses the need to address the motivational component of teaching and learning in his "tongue in cheek" equation:

$$e = m^2 c$$

where **e** = the e-learning outcomes

m = motivation

**c** = content presentation

To create a successful "e-learning" product, you need not only good content, but you must help the learner become internally motivated. Structuring a lesson as a game with scoring and points is one example of how learning can be engaging and fun.

Instructional design is a challenging, creative profession where you are learning new things all the time. For more information, visit one of the web sites in the References section, or better yet, get involved with a professional organization in your area. Contact your local chapter of the Society for Technical Communications (STC) or the American Society for Training and Development (ASTD) and attend a meeting. Networking with people already working in the field is an excellent way to get connected, stay in touch with ideas and trends, and find jobs.

As Confucius said, "The journey of a thousand miles begins with a single step." What's your next step into this exciting new career?

## Designing Courses as Learning "Safe Havens"

The old self-deprecation, "I usually learn things the hard way," has been around forever, probably because we all feel the same way. Learning through making mistakes is a universal experience.

Why then, are we so afraid of making mistakes? I submit that the culprit is our social environment, our perfectionist culture. At an early age, we internalize the feeling that we will be ridiculed if we make a mistake. We are socialized to feel shame for anything less than being perfect.

The tragedy of this is that our greatest teachers are our own mistakes. If we constantly avoid risking failure, we will never learn, grow, or excel.

Because of this, instructional designers should strive to construct a learning experience that counteracts this pernicious fear of failure. The learning experience must challenge the students; otherwise, they will not learn anything. At the same time, however, students must feel comfortable enough to risk a wrong answer or make a mistake without fearing that they will be ridiculed by other classmates or the instructor, or that their supervisor will receive a less-than-stellar report about class performance.

This article describes how instructional designers can employ four key enablers in their course design that will help foster a positive learning experience for students and diminish the students' fear of failure. I call this creating a learning "safe haven."

## The Four Key "C" Enablers

There are four key enablers that instructional designers can integrate into course designs to help foster a learning "safe haven" for students:

Conversation

- Confession
- Coaching
- Collaboration

Conversation - One way of fostering learning through mistakes is to structure your course design so that it allows the instructor time for short conversations or debriefs at intervals during the course. The instructor can facilitate the discussion by asking students to recount what they did right in the exercise, what mistakes they made, and what they could have done better. Discussion can also center on what was easy and what was difficult. If the instructor starts these discussion sessions early in the course, it helps establish an atmosphere of trust and sets the tone for the entire course. One technique I use towards the end of a course is to bring in a panel of experts as a bonus addition to one of these debriefs. These experts are typically those involved with the development of the product or process being taught, such as programmers, customer support staff, the HR manager, company founder, and so forth. This gives the students an opportunity to engage with someone besides the instructor, and many times, issues and concerns are expressed that the students were previously unwilling to share.

Confession - (This enabler is not so much a design element in your course, but rather a best practice that should be stressed during the train-the-trainer sessions.) Instructors can also encourage trust by discussing issues and mistakes they themselves have made when going through the class the first time. An instructor can also overtly exhort the students to take risks, by saying things like, "Go ahead! Bang on this computer, you won't break it!" or "The only dumb question is the one not asked." I have worked for many years with an instructor who is very adept at this. He has a real gift for disarming his students by telling them funny stories about all the mistakes he's made using the software they are learning. The unspoken message behind his selfdeprecatory humor is that the best way to learn the software is to be unafraid of making mistakes.

Coaching - As students are working on the practice exercises, it is tempting for an instructor to jump in and help a struggling student by solving the problem for him or her. A better instructional technique is to encourage students in a certain direction and then give them additional study time to solve the problem on their own. If, after a few minutes, the student is still on the wrong track, a good instructor can intervene and help the student. Good instructors never spoon-feed solutions, but rather help students figure out the right approach on their own. As an instructional designer, you can structure the course to allow time for this. You can also design exercises that have built-in decision points that provide the instructor coaching opportunities. Besides the regular step-bystep exercises common in much training, I like to provide case study skills practices where, using the skills they have just learned in the regular exercises, students apply them to different scenarios. Besides reinforcing skills, these practices also provide the instructor with more coaching opportunities.

Collaboration – Another key enabler for letting students learn from their mistakes is encouraging collaboration, in either pairs or small groups. Collaborative pairs or groups are usually better problem-solvers than individuals. Moreover, students who are reluctant to share that they are struggling may be more apt to share in a smaller work team or with another partner. As an instructional designer, you can design group or pair exercises, or include them as an option. Several years ago, we were instructing a class of Japanese students. We knew their English language skills were limited, so during the first morning of the first day, we went very slowly, pausing every few minutes and asking them if they understood what we had just taught. Invariably, everyone would look up at us, smile and say in unison, "Yes, thank you very much." We continued this way until our first break. Instead of leaving the room and taking their break, however, the students clustered around one of their peers who had the best English proficiency. They started peppering him with questions in Japanese,

and he reviewed with them the material we had just covered. Seeing this, we immediately changed our course structure, and gave the students permission to collaborate on each exercise instead of working individually. It took a bit longer to get through the course, yet by collaborating, the students were able to accomplish together what would have been difficult or impossible on their own.

## Conclusion

While much of the responsibility for fostering a safe learning experience lies within the instructor's provenance, the instructional designer also plays a key role.

Instructional designers should always keep in mind the social and emotional barriers to learning, and then work to mitigate these barriers in their course design. Just as architects and engineers keep safety paramount when designing buildings and bridges, instructional designers must keep the idea of a safe learning experience, or learning "safe haven," paramount when designing their courses. By structuring their courses to include facilitated conversations or debriefs, by building in time for instructors to discuss their own experiences and to coach their students, and by having students collaborate in pairs or teams, instructional designers will help the instructors establish a learning experience where it is safe for students to actively engage in learning and to risk mistakes.

## New IDL SIG Email Lists

The STC is considering changing all e-mail lists from Lyris to Mailman, and asked IDL to be the second SIG to pilot its use. So we've recently switched our Announcement and Discussion email lists to Mailman, which offers (among other things) much better access to archived content. In this article I'll explain what our email lists are, and show you how to customize Mailman to get the most out of this service.

#### WHAT'S AN EMAIL LIST?

To paraphrase the STC Online SIG definition, an email list is a set of email addresses which a special web server, called a list server, uses to send messages posted by subscribers to all of the other subscribers.

The IDL SIG has two email lists: an Announcement list and a Discussion list.

Our **Announcement** list lets a few administrators send messages to all the subscribers on the list. Subscribers cannot reply to the Announcement list. We use this list to tell SIG members about upcoming events and pass along important news. These announcements will be limited to an average of one per week.

You can "opt out" of the Announcement list by clicking the link at the bottom of a message. While we don't recommend taking that step (you'll miss out on important information that may not be otherwise available to you), receiving these emails is each member's individual choice.

Our **Discussion** list, on the other hand, lets any subscriber post a message to the list so that all subscribers receive it. (If you're not a list subscriber, you can't post a message.) An email discussion list is often referred to as a "forum" for subscribers to talk about a particular topic area. Each topic discussed is often called a "thread." The Discussion list is designed for collaboration, and in the short time since IDL switched to Mailman we've

enjoyed several very spirited and informative discussions.

### **GETTING AROUND IN MAILMAN**

To post a message, read archived messages, and manage your account options, go to <a href="http://mailman.stc.org/mailman/listinfo/stcidlsig-l">http://mailman.stc.org/mailman/listinfo/stcidlsig-l</a> (Note: This link also appears at the bottom of each Discussion list e-mail). Here's what you'll find on that page:

- Discussion List Archives A collection of prior postings to the list
- A link (<u>stcidlsig-l@mailman.stc.org</u>) to post a message to the list which—just like any other e-mail address—will open a new message window in your e-mail program. When you write your message and click Send, the server will deliver it to all the other list members.
- A form to fill out if you want to subscribe to the list. You must be an IDL SIG member in good standing in order to subscribe. This is a hidden list; the member roster is visible only to the SIG's list administrators. You can enter a password, or allow the system to generate one for you. You can also choose to receive the list as a "digest" or compilation of all the day's messages in one e-mail, rather than receiving each message as it comes in.
- A form that lets administrators access the member list
- A text box at the bottom of the page in which to enter your subscription e-mail address to change your subscription options, get a password reminder, or unsubscribe from the list. Enter your email address in this box, and click the button marked "Unsubscribe or edit options". On the next screen you can do three things: enter your password to log on and change your options, click the "Unsubscribe" button to leave the list, or click the "Remind" button to have your password mailed to you.

When you log on, you can change your name, your e-mail address, or your password, and tailor the delivery of your e-mail messages. Each of the delivery options are explained in some detail, so I won't go into all of them here. The big ones that you should know about are digest mode (one compiled message each day), putting your account on "hold" (no deliveries while you're on vacation, etc.), selecting whether to receive copies of your own posts to the list, and whether to receive an automatic monthly password reminder.

If you find the messages distracting, set a rule in your e-mail program to route them to their own folder, where you can browse them later. Or choose digest mode for just one big message each day.

We'll be sending weekly tips about all of these features (as well as some we didn't mention). If you need help with Mailman functionality, or if you'd just like to read more about it, you can find extensive user documentation here: <a href="http://www.gnu.org/software/mailman/users.html">http://www.gnu.org/software/mailman/users.html</a>

The overall response has been tremendous and very lively, and both the IDL SIG and the STC are learning a great deal from this pilot. So remember — even if you don't feel like posting, you can learn a lot (and have a great time) reading the discussions. We'll see you around the Discussion list!



# IDL SIG Leadership Among New STC Associate Fellow Honorees

Editor's Note: This is the second part of a two-part article that showcases members of the IDL SIG community who were honored at the 2006 STC Annual Conference in Las Vegas.

These are just two of eight IDL SIG members who were given special recognition at the 2006 STC Honors Banquet last May in Las Vegas. In addition, the following CIC SIG members were honored:

#### WHAT DO THESE HONORS MEAN?

Being elected as a <u>Fellow of STC</u> is the highest honor that can be bestowed upon an STC member. It means that the member has **attained the highest level of distinction in the field of technical communication**. This ranking is codified in the STC Bylaws as follows:

Fellow. The rank of fellow is conferred only upon associate fellows who have attained such eminence in the field of technical communication that the board, by a two-thirds vote of all members, deems them one of the select few who have distinguished the Society and the profession.

Associate fellows may not apply for the rank of fellow; they must be nominated by a committee of fellows. The rank of fellow is bestowed upon an individual only once. Fellows retain the rank as long as they remain members of the Society.

The *Jay R. Gould Award* for excellence in teaching technical communication honors the distinguished teaching career of Professor Gould, whose academic mentorship of technical communication students guided many men and women into the profession.

The award honors excellence in teaching that becomes true academic mentorship: the personal and professional concern that the best teachers extend to their students beyond the demands of the classroom and beyond even graduation as former students continue to grow throughout their professional careers.

To be eligible for the award, a nominee must have been a member of the Society for Technical Communication for ten years and must have been involved in post-secondary education for at least fifteen years.

As mentioned in part 1 of this article, being elected as an <u>Associate Fellow of STC</u> is the second highest honor that can be bestowed upon an STC member. It means that the member has **attained distinction in the field of technical communication**. This ranking is codified in the STC Bylaws as follows:

Associate fellow. The rank of associate fellow is conferred only upon a senior member who has attained distinction in the field of technical communication. Senior members may not apply for the rank of associate fellow; they must be nominated by a committee composed of fellows and associate fellows. A senior member may be elected an associate fellow if the member (1) has been active in the field of technical communication at least fifteen years, (2) has been a member of the Society at least ten years, and (3) has (a) been responsible for important work in the field of technical communication, (b) done notable original work that has contributed to the advancement of technical communication, or (c) made a significant contribution to the Society.

The rank of associate fellow is conferred only by a two-thirds vote of the entire board. The rank of associate fellow is bestowed only once upon an individual. Associate fellows retain the rank as long as they remain members of the Society, unless elevated to the rank of fellow. Not more than three percent of the Society's membership may hold the rank of associate fellow at any time.

#### HERE ARE REFLECTIONS FROM THE HONOREES

To celebrate the occasion, *IDeaL: Design for Learning* caught up with these honorees to get their perspectives on these wonderful honors.



ANN WILEY - STC FELLOW

IDeaL: What does it mean to you to be elected a Fellow of STC?

**Ann:** I appreciate the Fellows Nominating Committee's recommending me for election to Fellow, and election by the Board. This is really an honor bestowed by the members of STC, and that makes it particularly meaningful.

IDeaL: How did you celebrate receiving the good news?

Ann: In commemoration of my election I have begun a long delayed project to inventory the papers of the late Russell and Ruth Terry, Fellows of STC, and my papers related to the Rochester Chapter. # IDeaL: What does it mean to you to be elected an Associate Fellow of STC?

**Rebecca:** I was nominated by two of my former PhD students -- Donna Kain and Katherine Miles.


IDeaL: How did you celebrate receiving the good news?

## **IDL SIG Recognition Policy**

The IDL SIG recognizes the contributions of the membership in those areas that support IDL SIG goals:

- Build the instructional design skills of members at all experience levels, leveraging the knowledge of experienced members to deliver formal and informal guidance to the community of practice.
- 2. Provide a forum and mechanism for the free exchange of knowledge, ideas, and skills.

Committee chairs recommend members they feel have provided outstanding support of these goals in the following categories:

- Outstanding article for newsletter
- Quality and frequency of contributions to the discussion list
- Contributions to the web site, particularly the resource sections
- Speakers at IDL SIG events

The number of members recognized in each category is at the discretion of the committee chairs.

In addition to recognition of contributions that support SIG goals, individual members who have demonstrated outstanding foundational support of the SIG through their volunteerism will receive recognition. There are two categories of recognition available:

- Society-sponsored Distinguished SIG Service Award (DSSA) recipients are selected by vote of the Leadership Council. Guidelines and application for the DSSA will follow existing Society procedures.
- SIG Manager's Award recognizes the contribution of one outstanding member during the manager's term of office. The SIG Manager selects the award recipient.

The SIG Manager and DSSA awards are given annually at the STC conference. Other categories of recognition are awarded annually at the conference or by mail, at the discretion of the committee chair.
